The purpose of this Agreement is to set out the terms and conditions under which the Grant Recipient will be funded by the Fare network.

The Grant Recipient must agree and comply with the terms and conditions, and sign this Agreement in order to receive the funding.

## 1. Parties

**Fare** is a not-for-profit network constituted of formal and informal groups committed to tackle discrimination in football and further a positive change through the game.

Dragones de Lavapiés is a community based football club whose purpose is to empower children through play, to build friendship bonds and to grow global citizens, experiencing solidarity.

## 2. Background and focus

*Describe your organisation's background and work focus.*



Dragones de Lavapiés has as its mission to weave, from the sport and the competition, bonds of solidarity, respect and community, fostering the dialogue between people of very diverse cultures that live in this neighborhood of the center of Madrid. At the moment 170 children and young from 30 different national backgrounds play in the club, which promotes the UN Sustainable Development Goals with the tournament 17 Goals.

### **3. Description of the project**

*Describe the project and activities.*

The 17 Goles tournament in Freetown will be celebrated on the 14th of June with American International School and Lebanese International School and we will invite two public schools of the area too. The idea is to engage kids with very different backgrounds and status with the 17 global goals established by United Nations, in order to promote equalitarism and to fight prejudices against the poorer kids. Playing football together is the best way to break ethnic, social and economic barriers (all well very present in Freetown). And as the goals are part of a global agenda are a calling for everyone to act. The characters Dragones has created represent children from all over the planet playing together. The tournament will be played by kids of 10 and 11 years old (120 kids). Each team will be composed by a 20 percent of girls at least and will have a Global Goal to defend. Though parents will be invited, kids will come in school buses and there will be around 200 people watching. Nevertheless, there will be press invited.

Vocalist, songwriter, percussionist and luthier, Seydu was born in Freetown, Sierra Leone, in a family of musicians. He grew up listening to the songs of his mother, mix Fullah and Mandingo, and assimilating the rhythms that his grandfather played on the drums, experiences that have marked his musical identity.

Seydu founded the NGO "Diamond Child School of arts & culture" in 2005 to provide an opportunity for disadvantaged children and youth in his country. A short video will be recorded.



#### **4. Agreed terms**

##### **a. Acknowledging the Grant**

The Grant Recipient shall acknowledge the receipt of a Fare Global Grant on its website and social media, highlighting its purpose.

Failure to acknowledge our support is a breach of your funding agreement.

##### **b. Fare logo**

Grant Recipients are required to use the Fare and Global Grants logos on all printed and digital material in connection with the project once it has been approved.

Fare will provide the Grant Recipient with logos, which must be used for publicity.

Grant Recipients must not use the Fare logo on their letterhead.

##### **c. Monitoring process**

Grantees are responsible for managing the day-to-day operations of their grant but must keep Fare informed of key developments, changes, and publicity around it.

##### **d. Financial record keeping**

All original receipts, paid bills and financial records related to the Grant expenditure must be retained by the Grant Recipient, and submitted along with the final claim, to Fare.

The Grant Recipient shall not use the Global Grant funds for any other purpose other than what is agreed in the budget.

##### **e. Reporting**

After the completion of the project, Grant Recipients must submit a written and financial report. The written report should contain supporting evidence of the project and its activities, including high-resolution photographs, videos, press clippings, articles on websites, links on social media and receipts.



The financial report must include the actual expenditure, which will be checked against the Budget below (page 6). For grants of \$2,500 USD and \$5,000 USD it must also include the Grant provided by Fare and the match funding (a minimum of 25%).

The final report must be submitted within **one month** of the project end date. Failure to submit a report may cause the final payment to be delayed or not paid in full, and/or may cause Fare to refuse to consider further grant requests.

f. Risk and Liability

Fare requires all applicants to accept risks and liabilities associated with the proposed project including conflicts of interest, damages arising out of this grant and inadequate investment of the funding provided.

The liability of each party arises directly out of its obligations under this Agreement and every applicable part of it.

Dragones de Lavapiés represents and warrants that it will perform the Services promptly with reasonable skill and care and to the best of Dragones de Lavapiés ability.

All attachments to the Grant Agreement are hereby incorporated as part of the Agreement.

g. Disputes

In case of issues of concern or dispute, Dragones de Lavapiés shall address Fare staff directly and vice-versa. In the eventuality that the Fare staff is unable to resolve the dispute, the Fare board will intervene.

Fare may terminate this Agreement by giving the Grant Recipient ten days' notice, in writing, if it is determined that the Grant Recipient is not following the Guidelines for Global Grants Recipients and this Agreement. The Grant Recipient may terminate this agreement by giving Fare ten days' notice in writing.

In the event of termination, Fare reserves the right to take action to recover any funding already paid, or spent on unauthorised expenditure.

**5. Amount and time periods**

Fare hereby agrees to allocate \$1000 USD to the Grant Recipient to carry out the activities as described in the application form.



The allocated Global Grant is available to be spent as shown in the Budget proposal, which has to be completed by the Grant Recipient on page 5 and 6.

Fare may suggest certain amendments to this budget. Any further adjustments should be made in negotiation with Fare.

The effective period for the Grant is from 9 April until 31 August 2018.

Any expenditure spent before or after this period cannot be reimbursed.

The Grant is given on the condition that it is used for the project during the defined period. If the Recipient has not spent any the entire on the project by the end of it, the Recipient must, as soon as possible, notify Fare accordingly. Unless Fare notifies the recipient that the recipient may retain the unspent amount of the Grant, the recipient must return any unspent amount of the Grant to Fare.

## **6. Payments**

All Fare Global Grants will be paid in two tranches: 50% paid before implementation (15 days after you have accepted the grant) and 50% after delivery upon reception of a final report and evidence, as stated in the Payment Profile Table page 7.

## **7. Confidentiality**

Dragones de Lavapiés will keep secret and not disclose or permit to be disclosed to any person any confidential information relating to Fare or any of its dealings or proposed future activities.
